| 1974-1 | 7-22-74 | Annexing certain lands located in the Southwest quarter of Section 35, Township 2 North, Range 1 West and the Southwest quarter of Section 34, Township 2 North, Range 1 West, each parcel as more particularly described in the ordinance. |
